PRIVATE DRAINAGE EASEMENT

THIS INSTRUMENT is made this 19th day of May, 1997, by and between Stafford Construction, Inc., (Lot 54, Brighton at Mill Creek) herein called the "Grantor" and Brighton at Mill Creek Homeowners' Association herein called the "Grantee".

WITNESSETH

Grantor for and in consideration of value paid by Grantee, and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, grants, sells and conveys to Grantee, its successors and assigns, a perpetual easement for drainage lines with necessary appurtenances over, through, across and upon the following described property in Snohomish County, Washington, more particularly described on attached EXHIBIT "A".

Grantee, its successors or assigns, shall have the right without proper institution of any suite or proceeding at law, at times as may be necessary, to enter upon said property for the purpose of operating, construction, repairing, altering, or reconstructing of said drainage lines and appurtenances shall be accomplished in such a manner that the private improvements existing in said easement shall not be disturbed or destroyed, or in the event they are disturbed or destroyed, they will be replaced in as good a condition as they were immediately before the property was entered upon by Grantee.

Access to this easement is reserved for the City of Mill Creek and the City shall reserve the right, but not the obligation, to perform any needed service and maintenance on these drainage facilities necessary to insure that the drainage facilities are operating properly. It shall be the responsibility of the Homeowner's Association to reimburse the City for any service and maintenance costs incurred.

Grantor shall retain the right to use the surface of said easement, so long as said use does not interfere with the installation, operation and maintenance of drainage lines and appurtenances and so long as no permanent buildings or other structures are erected on said easement.
